OPENING REMARKS SPEAKERS

We are honored to have Lieutenant Governor Sheila Oliver and HMFA Executive Director Melanie Walter delivering remarks this morning. Hear from the leaders of these two agencies as they reflect on the work that's been accomplished in recent years and share what's to come.

The State of New Jersey through the NJ Department of Community Affairs (DCA) and the NJ Housing and Mortgage Finance Agency (HMFA), have long provided resources to support the community development sector as well as NJ homeowners and renters. Throughout the pandemic, these agencies served as a lifeline for residents, protecting tens of thousands from eviction and foreclosure. They administer programs our members rely on for financial support including the Affordable Housing Trust Fund, the Neighborhood Revitalization Tax Credit Program, the Special Needs Housing Trust Fund, and the Hospital Partnership Subsidy Program just to name a few.



Lieutenant Governor Sheila Y. Oliver

Commissioner of the NJ Department of Community Affairs

In addition to her role as Lieutenant Governor, she serves as Commissioner of the Department of Community Affairs, where she has led efforts to strengthen and expand initiatives for fair and affordable housing, community revitalization, homelessness prevention, and local government services that support New Jersey's 565 municipalities.

Across her career, Lieutenant Governor Oliver has worked in the public, non-profit, and private sectors, and has taught numerous college courses. She has served as a member of both the East Orange Board of Education and the Essex County Board of Chosen Freeholders. In 2003, she was elected to serve the 34th Legislative District in the New Jersey General Assembly. A trailblazer in every sense of the word, in 2010 she became the first African-American woman in state history to serve as Assembly Speaker, and just the second in the nation's history to lead a state legislative house.



Melanie Walter, Esq.

Executive Director, NJ Housing & Mortgage Finance Agency

Melanie R. Walter brings broad-ranging experience in government and community-related matters in New Jersey state government to her role as Executive Director of the New Jersey Housing and Mortgage Finance Agency (NJHMFA). Before joining NJHMFA in January 2021, Ms. Walter previously served as Department of Community Affairs (DCA) Director of

the Division of Local Government Services (DLGS) And Former Deputy Attorney General. In the role of DCA Director of the DLGS and Local Finance Board Chairwoman, she advocated for local government interests, revitalizing the Division's supportive initiatives and developing grant programs while overseeing the financial and operational regulation of New Jersey local units to help ensure fiscal solvency. Through these functions, she championed transparency measures as well as expansive open data and local education programming and enhanced local procurement, municipal officer certification, and distressed municipality resources. More recently, Ms. Walter has developed and implemented numerous COVID-19 response and recovery measures.

OFFICERS (1 Year Term)



Chair **Bridget Phifer** has served as Executive Director of Parkside Business and Community in Partnership (PBICP) since 1999. Since joining PBICP, she has grown the organization's budget tenfold. Staff has increased from one (Ms. Phifer) to half a dozen staff as the housing effort has expanded, and homeownership education, marketing and neighborhood planning programs have been created. Strategic partnerships with foundations, other community development

organizations, corporations and government agencies have been critical to this success. Ms. Phifer has previously served on the Network Board of Directors a Vice Chair.



Vice Chair Edward Bethea serves as the Executive Vice President and Chief Operating Officer of Gateway Community Action Partnership. He oversees all financial, managerial and revenue-generating departments and activities within the agency. He is the chief negotiator of all contracts and leases and serves as chief developer on all construction projects. He is responsible for the Operations, Finance and Human Resources Departments as well as, Head Start, Health Services,

Economic Development, Social Services, Information Technology, Weatherization, Property Management and Facility Maintenance. He brings years of experience in tax consulting, financial planning, cash flow projection and asset management to Gateway, and maintains approval authority on all agency spending. He is also directly responsible for the interactions between Gateway and financial institutions and governmental entities. Mr. Bethea currently serves as President of the Bridgeton City Municipal Council and joined the Network Board of Directors in 2020.



Treasurer Dan Antonellis has served as President of Region Nine Housing Corporation (RNHC) since 2012, developing high-quality affordable housing and providing services to families, seniors and disabled individuals. Prior to becoming RNHC President, he served as a Staff Representative for the Communications Workers of America, Local 1038 and spent nearly 25 years at the New Jersey Department of Labor prior to that. He is a former Vice President and Board President of the

ARC Mercer and a founding member of the Board of Orphan Sponsorship International (OSI). Mr. Antonellis joined the Network Board of Directors in 2018.

Susanne Byrne, Chief Executive Officer, York Street Project

Susanne Byrne joined the York Street Project in her current role in 2009, but she is no stranger to its programs. With a one year hiatus, serving as the Homeless Planning Coordinator for Hudson County, she spent 10 years prior with The Project. She served as the Caseworker/Advocate for St. Joseph's Home from 2000 to 2008 and as the Assistant to the Director of The Nurturing Place from 1998-2000. Ms.

Byrne holds a Masters in Administrative Science degree from Fairleigh Dickinson in Teaneck, New Jersey and a BA degree with a major in English and a concentration in Political Science from St. Michael's College in Vermont. She is a member of the Hudson County Human Services Advisory Council, Hudson County Alliance to End Homelessness, the Hudson County Affordable Housing Coalition, the Housing and Community Development Network of New Jersey, and the Antipoverty Network of New Jersey. Within these groups, she serves on a variety of Executive Boards and sub-committees advocating for the poor.



Pilar Hogan Closkey, Executive Director, Saint Joseph Carpenter Society

Pilar Hogan Closkey, PE, PP, AICP joined Saint Joseph Carpenter Society in 1998 as the Operations Manager and, in 2004, was named the Executive Director. Ms. Closkey graduated from the University of Notre Dame with a B.S. in Civil Engineering and worked for seven years in the field of consulting engineering. Ms. Closkey then pursued her Master's degree in Regional Planning at the University of North Carolina

- Chapel Hill and worked for a non-profit tax credit developer. She is licensed as a Professional Engineer and a Professional Planner in New Jersey and is nationally certified with the American Institute of Certified Planners. As the Executive Director, Ms. Closkey reports to the Board of Trustees and is responsible for the day-to-day activities of SJCS. She returns to the Network Board of Directors in 2023.



Taiisa Kelly, CEO, Monarch Housing Associates

Taiisa joined Monarch Housing Associates in March of 2006. She has experience in housing development working with federal, state and local funding sources to secure financing for special needs housing projects. In October of 2007, Ms. Kelly joined the Ending Homelessness Team where she works with local governments, nonprofits and community stakeholders to develop coordinated strategies to end homelessness. On

January 1, 2019, she was appointed as CEO. She has extensive experience in working with community stakeholders on homeless planning activities. As a member of the Ending Homelessness Team Ms. Kelly guides communities through the process of developing 10 year plans to end homelessness and has completed 3 community plans in the past 2 years. Mrs. Kelly received her B.A. in psychology and anthropology from Rutgers University.

Jessica Padilla-Gonzalez, Executive Director, Housing Partnership NeighborWorks HomeOwnership Center

Jessica started her career at the Housing Partnership NeighborWorks HomeOwnership Center as the assistant counselor and in 2013, she became the Executive Director. The Housing Partnership NeighborWorks Homeownership Center is a HUD approved nonprofit agency that provides financial

education and one-on-one financial coaching for first time homebuyers. The organization also offers post purchase education, foreclosure counseling, and administers the sale of income restricted homes throughout Morris County. Ms. Padilla- Gonzalez is a member of the Affordable Housing Professionals of New Jersey, Housing Alliance for Morris County, North Central Jersey Association of Realtors, and FDU Steering Committee for Women in Non Profit Leadership, and on the Advisory Board of the National Association of Hispanic Real Estate Professionals. She is a graduate of the College of Saint Elizabeth with a Bachelor's Degree in Sociology; she also completed her Masters in Administrative Science from Fairleigh Dickinson University.

John was born and raised in the City of New Brunswick and works in NYC and internationally as a freelance actor. Through his work at coLAB Arts, he is committed to creating projects that use the arts as a lens to examine complex issues that affect community. While serving as Director of Education for coLAB Arts, he has produced main-stage productions and initiated educational residencies in several

central New Jersey schools. Mr. Keller curates and directs coLAB Arts' Trueselves oral history and theater project in partnership with the Pride Center of New Jersey and Rutgers Oral History Archive. He is also the Board Chair for New Brunswick's Town Clock Community Development Corporation. John earned his undergraduate degree at Holy Cross and holds a Masters in Fine Arts in Acting from Rutgers University, Mason Gross School of the Arts. He has taught theater at all grade levels in a variety of residency programs as well as at Rider University, Westminster Choir College and is currently teaching Theater for Social Development at Rutgers University, Mason Gross School of the Arts, and Acting at Fairleigh Dickinson University.

Jerry Green Legacy Award



SENATOR RONALD L. RICE

As one of the longest-serving state senators in New Jersey history, Ronald L. Rice served the people of NJ's 28th Legislative District until his retirement at the end of August. For 18 years, Senator Rice chaired the New Jersey Legislative Black Caucus, whose mission is to "prioritize legislative and policy agendas to ensure that people of color, in particular, are treated equally, and justly when it comes to social justice, economic justice, and criminal justice reform." Throughout his unparalleled career, he never backed down from doing what is right for the people who need it most, leading with principles, integrity and compassion. We honor Senator Rice for his tenacious leadership creating the Lead Hazard Control Fund and the State Rental Assistance Program, two programs that are unique to NJ and exist because he

fought to make them a reality. He also shepherded the Foreclosure Mediation Program, renter protections and a host of other housing programs. Senator Rice has been a fierce advocate for NJ residents and a true champion for our most vulnerable neighbors and communities. He will be missed in the State House.

Hall of Heroes Inductee



CONNIE MERCER

Connie Mercer founded HomeFront from her kitchen table 31 years ago to organize volunteers to deliver meals and clothing to homeless families living in motels along Route 1 in Mercer County. The organization has grown to over 100 employees and over 3000 volunteers to comprehensively address the needs of the homeless. In 2021, the agency answered 52,439 calls for help for shelter, homelessness prevention, permanent service-enriched housing, job training, children's programming, food, and other essentials. She helped found the Shelter Providers Consortium of NJ that brings together homeless shelters and advocacy groups together to address needs of shelters and their residents. Last month, Connie left HomeFront to focus her efforts on addressing the issue of homelessness more broadly at the state

and national levels by leading the Shelter Providers Consortium as the Executive Director of the NJ Coalition to End Homelessness. We honor Connie for being a strong partner of the Network, advocating for policies to end homelessness as well as serving on our Board of Directors. The Network looks forward to working with Connie as she embarks on her newest endeavor.

SENATE MAJORITY LEADER TERESA RUIZ

In 2007, Senator Teresa Ruiz became the first Puerto Rican elected and later the highest ranking Latina legislator in state history after being elected Senate Majority Leader. She represents the 29th Legislative District and is a strong voice for NJ's vibrant Latino community. She has fought for equity in educational spaces, acting as the leading force in expanding access to early childhood education throughout the state. She also spearheaded the law to build on the federal free and reduced meal program so that all students who qualify for the program could receive breakfast and lunch at no cost, eliminating the reduced category. The senator has also focused on expanding employment opportunities for underserved communities, sponsoring bill packages to expand apprenticeship programs in the state and increase teacher diversity.

For being a sponsor and a strong advocate for many of the Network's legislative priorities including requiring Lead Paint Inspections, Land Banking, and expanding liability of limited liability companies acting as a residential landlord, the Network honors Senate Majority Leader Ruiz as the 2022 Community Development Champion.

NJ CENTER FOR NONPROFITS

For 40 years, the NJ Center for Nonprofits has worked to build the power of our state's nonprofit community. Their vision of advancing a civically engaged society and equitably delivering a thriving quality of life to all communities throughout the state of New Jersey is a vision shared by the Network in our efforts build a thriving NJ. Through training opportunities and resource

sharing, the NJ Center for Nonprofits has been a strong support for the nonprofit community. Under the leadership of President and CEO Linda Czipo, the New Jersey Center for Nonprofits has been a highly visible leader, champion, convener, and resource for and about New Jersey's nonprofit community and an exceptional community partner.

Advocacy and Organizing Award



LEAD-FREE NJ

Lead-Free New Jersey is an equitable and inclusive collaborative working to ensure that New Jersey's children are free from lead poisoning and that our environment is lead-safe by advocating for changes to state and local policy. The collaborative also seeks to eliminate racial and economic inequities by focusing on legacy lead hazards in low-income communities and/or communities of color. The idea at the core of Lead-Free NJ is that lead-free policies must be representative and equitable to create lasting change. This year, Lead-Free NJ fought for and won a significant investment

for lead remediation in the state budget. The collaborative's advocacy ensured that lead remained a priority for decision makers paving the way for a truly lead-free NJ.



Outstanding Municipal Partner – Neighborhood Revitalization



BURLINGTON CITY & HABITAT FOR HUMANITY OF SOUTH CENTRAL NJ

After receiving funding through New Jersey's Neighborhood Preservation Program, Burlington City partnered with Habitat for Humanity of South Central NJ to help revitalize the city's New London District. Together, Habitat

for Humanity and Burlington City worked to improve the neighborhood for residents, property owners, and businesses alike within the district. The municipality helped identify projects, hosted town halls, participated in events and so much more! Through this partnership, Habitat built numerous homes in the New London District and offered home repairs for current homeowners. Burlington has always been good to Habitat by donating properties for affordable homeownership and by spreading Habitat's mission through social media and marketing.

Outstanding Municipal Partner – New Development



CITY OF NEWARK & URBAN LEAGUE OF ESSEX COUNTY

Located in the City of Newark's West Ward, the Fairmount Heights Homes Phase I project was realized through a partnership between the City of Newark and the Urban League of Essex County (ULEC). The municipality sold ULEC the

vacant land at a discounted price and provided \$595,000 in HUD HOME funding to subsidize the construction of the homes thereby making them affordable for area residents. Several community meetings were held to develop a neighborhood plan. There, residents requested more affordable homeownership opportunities to retain area families as a form of increasing economic wealth. The Mayor of Newark, Ras Baraka, has included affordable homeownership development in his housing plan for the next 5 years. As a result of this partnership, ULEC was able to build two- and three-family homes ranging from \$240,000 - \$350,000. These homes are certified energy star and meet green community standards; they are built with metal roofs and hardy plank siding.

Outstanding Municipal Partner – New Development





CITY OF BRIDGETON

The City of Bridgeton is home to the RiverGrove Apartments, a 100 percent affordable rental community featuring 68 affordable homes. The project is the result of the joint efforts between Gateway Community Action Partnership, the Cumberland Empowerment Zone Corporation, and Eastern Pacific Development. The City of Bridgeton provided a PILOT

of 5 percent per annum for the project which is supplemented by other financing partners including the NJ Housing and Mortgage Finance Agency, Enterprise Community Investments, the USDA, and TD Bank. RiverGrove includes 34, three-bedroom duplexes, totaling approximately 1,300 square feet each. 52 of the apartments also have an attached garage. The project includes 40 USDA subsidized rental units for full-time farm workers, and 28 units which will be rented at market rates. Amenities include a range, refrigerator, dishwasher, garbage disposal, gas heat, electric central air, on-site property management, and planned social activities.

Outstanding Municipal Partner – Healthy Homes and Communities





In Newark's South Ward, the community identified concerns about the lack of quality early childhood education options. Out of that concern, the Clinton Hill Early Learning Center was born. The Center was designed in collaboration with two experienced early childhood providers, La Casa de Don Pedro, the city's largest community-based early childhood provider, and Clinton Hill Community & Early Childhood Center, which has operated a high-quality early childhood program in the neighborhood for more than 30 years. The

partnership leverages 48 federally funded Early Head Start seats provided by La Casa de Don Pedro and 150 pre-K seats awarded to Clinton Hill Community & Early Childhood Center. This light-filled, two-story facility transforms a long-vacant blighted site into a 40,000-square-foot facility focused on learning and early childhood development. It also features 16 classrooms – capable of offering educational and extended child care services for nearly 200 children, from birth to 5 years old – a secure inner courtyard, a multipurpose room that is available for community use, a family child care resource room and a commercial kitchen. Newark Mayor Ras Baraka and Newark Public Schools Superintendent Roger Leon stressed how this new investment in the Clinton Hill community aligns with their shared commitment to ensuring that every child in Newark has a safe and healthy start in life.

Outstanding Community Partner





MORRIS HABITAT FOR HUMANITY & ROXBURY HIGH SCHOOL

The 501 Edith Road Project is a collaboration between Morris Habitat for Humanity and Roxbury High School. Under the leadership of Roxbury HS Structural Design teacher Frank Caccavale, students built a single-family home through a variety of technical and construction skills. Students followed the process of building a modular home being guided each step of the way from planning to final completion. The home was built in two modules that were transported to the site at 501 Edith Road in Landing. There the modules were secured to the foundation and to each other. During class, students developed many different skill sets from reading architectural drawings to framing, to electrical and plumbing systems and more.

Outstanding National Housing Trust Fund Award



TRIPLE C HOUSING

Administered by the NJ Department of Community Affairs, the National Housing Trust Fund is a federal housing program exclusively focused on providing states with the resources they need to serve households with the most acute housing needs. In 2016, the first distribution of \$174 million in Housing Trust Fund dollars were allocated to states. To date, New Jersey has received over \$85 million through the program. Since the beginning of the COVID pandemic, Triple C

Housing has been approved for five projects in Middlesex and Ocean Counties totaling 10 homes in 6 properties. These projects have allowed Triple C to house two individuals and 8 families (for a total of 33l members) who were previously homeless, victims of domestic violence, or where the head of household has a diagnosed mental illness. The over \$3,850,000 in capital funding has allowed Triple C to leverage nearly \$750,000 in private financing. Permanent housing is one of the leading social determinants of health; these properties are transforming lives by providing residents with a safe, quality, affordable homes in a healthy community.
