Jon A. Carnegie is Executive Director of the Alan M. Voorhees Transportation Center at Rutgers, The State University of New Jersey and an adjunct member of the faculty at the Edward J. Bloustein School of Planning and Public Policy at Rutgers. Jon serves as the principal investigator for a variety of research and planning projects involving a range of land use, transportation and environmental policy topics. His expertise includes: transportation, land use and environmental planning and policy; community development; public engagement; vulnerability/risk assessment; emergency management and evacuation; community impact analysis; sustainability; environmental justice; and equity issues related to traditionally underserved populations. Jon is the Project Director for Together North Jersey, a HUD-funded Sustainable Communities Regional Planning initiative led by the Bloustein School at Rutgers University. This three-year project includes extensive public outreach and community engagement and will result in the development of a long-range Regional Plan for Sustainable Development for 13 north New Jersey counties. In addition to outreach, the planning process also includes scenario planning and a fair housing and equity assessment that is examining how historic, current and future policies and public infrastructure investment decisions have or may impact traditionally underserved populations in the region.

Previously, Jamieson directed the Pace Center for Civic Engagement and taught in the Politics department at Princeton University. She also taught at Haverford College, the University of Pennsylvania, and Rutgers University and was a visiting scholar at the Institute for Advanced Study. Jamieson was educated at Bryn Mawr College (AB) and Rutgers University (MA, PhD). Her research and teaching focus on the relationship between law and political power, and she is particularly interested in issues of discrimination and inequality of opportunity and resources. She is the author of *Real Choices: Feminism, Freedom, and the Limits of Law*, as well as articles and reviews on subjects ranging from surrogacy to speech codes. Her recent scholarly work explores issues of discrimination and punishment related to gender identity and expression, with particular emphasis on the force of law felt by trans and gender non-conforming people in institutions ranging from prisons to marriage.

Jamieson lives with her spouse and their two children in Princeton, New Jersey, where she serves as president of the trustees of the Princeton Public Library, as well as trustee of the New Jersey Council for the Humanities and the Council of New Jersey Grantmakers.
